ORDINANCE NO. 1489

AN ORDINANCE AMENDING AND RESTATING TITLE IV, CHAPTER 405, SECTION 405.020 OF THE MUNICIPAL CODE OF THE CITY OF MULVANE, KANSAS RELATING TO OFFICIAL ZONING MAPS.

WHEREAS, it has been determined by the governing body of the City of Mulvane, Kansas (the "City") that it is in the best interest of the City to amend and restate Title IV, Chapter 405, Section 405.020 of the Municipal Code of the City of Mulvane (the "Code"), so as to incorporate the Flood Insurance Rate Maps dated December 22, 2016.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MULVANE, KANSAS:

SECTION 1. Title IV, Chapter 405, Section 405.020 is hereby deleted and amended to read as follows:

SECTION 405.020. OFFICIAL MAPS

There are further herein incorporated by reference and adopted Official Zoning Maps delineating the boundaries of zoning districts and the classification of such districts, which maps shall be marked "Official copy of zoning district map incorporated into zoning regulations by adoption of Ordinance No. 1432 by the Governing Body of the City of Mulvane on the 7th day of July, 2014, as amended from time to time" (which include the Flood Insurance Rate Maps (FIRM) dated December 22, 2016 for Sedgwick County and Flood Insurance Rate Maps (FIRM) dated December 22, 2016 for Sumner County). The same shall be filed with the Zoning Administrator to be open for inspection and available to the public at all reasonable business hours.

SECTION 2. This Ordinance shall take effect on and be in full force after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary hereof certified as legally accurate and sufficient by the City Attorney.


