WATER SERVICE AREA TRANSFER AGREEMENT

This Agreement is entered into this 1 day of May, 2017, by and between the City of Mulvane, Kansas, a Kansas municipal corporation (hereinafter referred to as the "City"); Rural Water District No. 3, Sedgwick County, Kansas (hereinafter referred to as the "District"); and Nottingham Estates at Hunters Pointe, LLC, a Kansas limited liability company (hereinafter referred to as the "Developer").

WHEREAS, the City owns and operates a waterworks and water distribution system serving land within its corporate limits; and

WHEREAS, the District is a rural water district organized and existing pursuant to K.S.A. 82a-612 et seq. The District provides water service to customers and property located within the territory of the District and has debt obligations implicating 7 U.S.C. § 1926(b); and

WHEREAS, the Developer intends to develop ten (10) acres of real property located within the City's corporate limits and the District's territory and legally described on Exhibit A attached hereto (the "Property"); and

WHEREAS, the Developer desires the City provide water service to the Property; and

WHEREAS, the District has no facilities within the Property and intends, upon proper petition by Developer and legal procedures pursuant to K.S.A. 82a-646, to release the Property from its territory and allow the City to provide water service thereto.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

1. <u>The Property</u>. The Property is depicted on Exhibit A attached hereto. The District has no benefit units upon the Property.

2. Pre-Release Procedure.

- A. Developer. The Developer herewith submits to the District a petition for release of the Property from District territory pursuant to K.S.A. 82a-646 (the "Release Petition").
- B. District. The District agrees, upon receipt of the Release Petition in proper form to consider release of the Property from the District's territory pursuant the procedure set forth in K.S.A. 82a-646, but no later than 45 days from receipt of the Release Petition.

3. Water Service.

A. Upon release from the District's territory, the City shall assume responsibility for providing all water service to the Property. The District agrees to allow the City to provide all water service to the Property, agrees that no additional debt obligations implicating

7 U.S.C. § 1926(b) shall be placed on or issued in reliance upon revenues from the Property, and agrees that the District shall not provide any water service to the Property.

B. Provided the Property has been released from the District's territory, the City and Developer shall each pay to the District a lump sum of \$5,353.63, for a total payment of \$10,707.26. Neither the amount of this payment, nor any other liability of the City to the District, shall be increased by new water customers within the Property after the date of this agreement.
